JURISDICTION

FACTUAL ALLEGATIONS

In the 90 days prior to the commencement of plaintiff's bankruptcy case, for the benefit of defendant, while defendant was a creditor of plaintiff, on account of debt allegedly owed by plaintiff, while plaintiff was insolvent, defendant garnished, seized, and received approximately \$607.52 in pre-petition wages from plaintiff, that enabled defendant to receive more than defendant would have received if plaintiff's bankruptcy was a case under Chapter 7 and the garnishment and seizure had not occurred.

CAUSE OF ACTION

(11 U.S.C. § 547)

Plaintiff incorporates the allegations above by reference.

9.

Under 11 U.S.C. § 547(b), plaintiff is entitled to recover the prepetition wages defendant garnished in the 90 days prior to the commencement of her bankruptcy case.
